Brought up that we will have to raise irrigation rates so we can continue to provide water from the wells for the ditches.

Terry – Frank wants to know if there's anything Terry is worried about. Terry only is worried about people needing the spring water and it not being there and finding out that Shumway ditch is on a different schedule.

Ross – would like a copy of their schedule so we know what's going on that ditch.
